# DAY 2 - Saturday, August 26, 2023

# Fair Oaks Farm, Half Century of Progress Farm Show and Champaign, Illinois

This morning we have a tour of Fair Oaks Farm, one of the largest dairy farms in the United States. Here we will have a two part tour which includes the Dairy Adventure to see the future of dairy farming in the Robotic Dairy, and the Crop Adventure to learn all about modern crop farming practices, the importance of our soil and the future of farming in order to feed 7 billion people and counting. Late morning we will depart Fair Oaks Farm to travel to Rantoul, IL to visit the Half Century of Progress Farm Show. The Half Century of Progress Farm Show is the premier working vintage farm show in the U.S. Held the weekend before the Decatur Farm Progress Show, the Half Century of Progress Farm Show allows visitors to experience what farming and agriculture was like 50 years ago and beyond with live demonstrations, attractions, and fellowship. Our overnight accommodations will be at the Drury Inn and Suites in Champaign, IL where we stay for the next three nights. Each evening during your stay, you may wish to join the hotel's "5:30 Kickback" to enjoy some hot snacks and a complimentary beverage. **(B)** 

## **DAY 3 – Sunday, August 27, 2023**

## Indianapolis Motor Speedway Museum and Champaign, Illinois

Departure this morning takes us to Indianapolis, IN to visit the Indianapolis Motor Speedway Museum. The Indianapolis Motor Speedway Museum's mission is to preserve and share one of the world's premier collections of automotive and motor racing vehicles and artifacts, with special emphasis on the Indianapolis 500-Mile Race. Located within the famed 2.5-mile Indianapolis Motor Speedway oval, the IMS Museum collection encompasses automobiles and artifacts representing more than a century of Indianapolis 500 culture, drama and competition, plus vehicles representing NASCAR, Formula One, American short-track racing, drag racing and motorcycles. The Indianapolis Motor Speedway Hall of Fame – comprised of drivers, team owners and personalities who have had a significant impact on IMS – is also housed at the Museum. It also houses two Indianapolis Motor Speedway gift shops. We also have a short guided tour "behind the scenes" which may include a visit to the Media Centre, the 10<sup>th</sup> floor of the Pagoda, Victory Podium and Timing and Scoring area, depending on facility availability on the day of visit. Late afternoon we arrive back at our accommodation in Champaign, IL. **(B)**

antique tractors, farm equipment, Galva-made products, and a world famous International Harvester Tractor Collection

#### **Legal Names/Copy of Passport**
